Hours of operation:	8 am - 5 pm
	While we have access to the playground, we will not be going on any field trips or utilizing the minibus.
Closures	LASER will be closed on Labor Day, Thanksgiving and the Friday after, Christmas Eve and Christmas Day. You will not be charged for care on these days.
No-School Days:	No-school days, such as October 9, November 11, November 23-25th are included in the Full-Day registration. If those days fall on the days of the week you are registered for, you are signed up for those days and they will be included in your tuition.
	Due to safety and staff considerations, we are unable to provide drop-in care on these days.
Sites & Capacity:	Bryant and Laurelhurst locations are available for care. Limited spots are available.
Safety:	Children and staff will be required to wear masks both inside and outside, unless drinking or eating.
	Staff and children will be required to take a daily health screening upon arrival.

Remote Learning Support:	We will do our best to support the remote learning provided by Seattle Public Schools. However, there are many considerations, such as internet bandwidth, electric availability, staff-to-child ratios, etc. that may affect our ability to do so. Our main priority is the safety of the children, so we will not be able to offer tutoring or educational guidance.
	Please make sure your child brings their laptop (or iPad), charger, passwords/log-in information, headphones, daily class schedule, notebook, pencil and any other accessories needed for remote learning.
Lunch & Snacks:	Students are required to a bring NUT-FREE, nonperishable lunch. If the student's food contains nuts, it will be thrown away.
	LASER will provide a morning and afternoon snack.

Registration:	The after-school registration that was previously done in May will be frozen until in-person school instruction is resumed. Registration for the Full-Day Care is online via this link: https://campscui.active.com/orgs/LASERChildcare?season=2873805 Parents may register by day of the week. Priority will go to children of essential employees and those registered for full-time care.
Tuition and Fees:	The tuition is \$80/child/day.
	We can accept DSHS and City of Seattle Childcare Assistance Program subsidies but are unable to offer sibling discounts at this time.
	Due to the constant changes in requirements during the COVID-19 pandemic, the cost of care is subject to change; enrolled parents will be given adequate notice of any rate changes.
Billing & Refunds:	Parents will be billed monthly (similar to the after-school program).
	Parents will be responsible for the full tuition of all registered days — refunds or credits will not be issued for missed days (due to illness, vacation, suspension, etc.) even if a four-week notice is given.
	For a full refund, a four-week notice must be given for permanent cancellations/reduction of days in a student's schedule.
End Date	End date would be December 18, unless remote learning is extended for

Winter Quarter.
